Family Memberships entitle the member, spouse, and dependents, age 23 or under to membership privileges. Children on a parent's membership will age out on their 24th birthday unless they remain a fulltime student.

Junior Memberships require the name, address, and signature of the parent/guardian responsible for payment of dues. Junior memberships have privileges Monday-Thursday anytime and on a full-in basis only on Fridays, Saturdays, & Sundays.
